Subject:- Grant of Conditional Permission to Shri Gangadhar Shastri Gune Ayurved Mahavidyalaya, Vishrambaug, Dist. Ahmednagar- 414001, Maharashtra (AYU0144) with 50 seats (63 seats Including EWS) in UG (BAMS) course for the academic session 2022-23 under section 28 of NCISM Act, 2020 and relevant regulations thereunder-reg.

Sir/Madam,

With reference to the subject mentioned above, I am directed to inform you that in pursuance of the provision of National commission for Indian System of Medicine Act, 2020, the Indian Medicine Central Council Act,1970 (48 of 1970) has been repealed with effect from the 11th day of June, 2021. With effect from the said date, the Central Council of Indian Medicine constituted under sub-division (1) of section 3 of the Indian Medicine Central Council Act, 1970 (48 of 1970) shall stand dissolved. Now, in exercise of the powers conferred by sub-section (3) of the section 1 of the said Act, the Central Government hereby notifies that all the provisions of the National Commission for Indian System of Medicine Act, 2020 has been come into force with effect from the 11th day of June, 2021 and as per regulation 59 (2) of The National Commission for Indian System of Medicine Act, 2020, Medical standards, requirements and other provisions of the Indian Medicine Central Council Act, 1970 and the rules and regulations made there under shall continue to be in force and operate till new standards or requirements are specified under this Act or the rules and regulations made there under.

Further, the provision of concerned regulations which are inconsistent with the provision of NCISM Act, 2020 shall not be applicable.

- Further, to assess the available facilities of teaching, non-teaching, Hospital staff, practical training and other infrastructure facilities at your college namely Shri Gangadhar Shastri Gune Ayurved Mahavidyolaya, Vishrambaug, Dist. Ahmednagar- 414001, Maharashtra (AYU0144) inspection of your College was conducted on 28.07.2022 and 29.07.2022 on virtual mode as a part of annual visitation by the visitation team of Medical Assistant and rating Board, NCISM to process the Conditional permission with 50 seats (63 seats Including EWS) in UG (BAMS) Course under Section 28 of NCISM Act 2020 for the A.Y 2022-2023.
- 2. Further, the visitation report and all other related documents were assessed in terms of the enforced regulations namely, the "Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Ayurveda Colleges and attached Hospitals) Regulations, 2016" and provisions under the NCISM Act, 2020 and relevant Regulations there under, and on the basis of Relaxation policy issued by the NCISM dated 16.03.2022.
- 3. As per the direction of President, Medical Assessment and Rating Board for Indian System of Medicine (NCISM), the assessment report was placed in the fifth Board meeting of Medical Assessment and Rating Board for Indian System of Medicine (NCISM) held on 29.08.2022. On careful examination of the assessment report it is found that your college is fulfilling the notified & approved criteria, hence Board decided to issue the Conditional permission with 50 seats (63 seats including EWS) in UG (BAMS) course for A.Y. 2022-23.
- 4. Therefore, it has been decided by the President, Medical Assessment and Rating Board for Indian System of Medicine to grant conditional permission to Shri Gangadhar Shastri Gune Ayurved Mahavidyalaya, Vishrambaug, Dist. Ahmednagar- 414001, Mahavashtra (AYU0144) with 50 seats (63 seats including EWS) in UG (BAMS) course for the academic session 2022-23 under section 28 of NCISM Act, 2020 subject to the condition that college is fulfilling the following requirements:-
  - The college shall submit an undertaking in the form of affidavit duly notarized within one month explaining
    the details of providing EPF and ESI facilities to the teaching, non-teaching staff of the Colleges/Hospitals and
    regularly paying the same as per the provisions of Employees' Provident Funds and Miscellaneous Provisions
    Act, 1952 & ESI Act, 1948 and relevant Rules and Regulations.
  - III. It is further informed that minimum 15% of undergraduate seats of the permitted intake capacity of 50 seats (63 seats including EWS) in UG (BAMS) seats shall be treated as all India quota. The counseling for seats under all India quota shall be conducted by respective counseling authority as designated by Central Government for A.Y. 2022-23 and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned Counseling Authority of that State/UT. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Government/NICSIM for all India course or the students and interesting authority.

NUISM Act & Regulations thereunder.

- 6. Discrepancies, if any, may be immediately brought to the notice of Medical Assessment and Rating Board for Indian System of Medicine, NCISM.
- The following requirements should be fulfilled by the college by 31st December, 2022 and send a compliance report to get permission for the session 2023-24:
  - all the requirements of Minimum Standard of infrastructure and teaching & training facilities as specified in Regulation 3 of the "Indian Medicine Central Council (Requirements of Minimum Standard for undergraduate Ayurveda Colleges and attached Hospitals) Regulations, 2016;

all the requirements of the Indian Medicine Central Council (Minimum Standards of Education in Indian Medicine) Amendment Regulations, 2016 (for Ayurvedate) 1

- all the requirements under the provisions of the NCISM Act, 2020 and relevant Regulations made thereunder HIY should be fulfilled in toto; and
- The fulfillment of the conditions given above may be made within the time period specified and compliance report. should be submitted by the college to President, Medical Assessment and Rating Board for Indian System of Medicine. The Medical Assessment and Rating Board for Indian System of Medicine will verify that the conditions have been fulfilled for considering the permission from the academic session 2023-24.
